

# Contacts in Canada & the U.S. Territories

Call Upon Your Best Detective Skills





### Develop a Plan for Obtaining Information

- Determine what programs you want to offer
- Establish a priority for contacting the territory or province authorities
- Find websites that appear to be established by the education authority in the territory or province
- REVIEW THE REGULATIONS prior to any contact
- Search the website for the correct person to contact
- Revisit the websites periodically to update contacts and check for changes in regulations



## Documentation





#### Documentation

- Save correct website to your "Favorites"
- Save copies of all emails and letters to authorities
- If no response within a determined timeframe –
   Contact again
- Save copies of all responses
- Contact "non-responders" once a year to attempt obtaining a response.



## Implementation

- Inform management of status of responders periodically
- Determine how to proceed with "non-responders"
- Inform Admissions office of which territories and Canadian provinces are acceptable to open admissions
- Inform other pertinent institution offices of status



## Examples of Territory & Province Interactions

- Puerto Rico Must apply to be on the Certification Registry of Exempt Institutions
- Guam Must go through the University of Guam
- Be persistent in obtaining responses
- When sending letters Always send certified with Return Receipt
- Tell them how you interpret their regulations

  - E-learning decentralized between Continuing
     Education at main campus and regional campus center
  - State Authorization
     Committee MUDESA
    - General Counsel
    - Representatives from all academic divisions, IT, Registrar, Provost

#### **2011-2013**

- E-learning Advisory Council (ELAC) charged with developing institutional elearning strategy
- Transition to further decentralization of e-learning
  - E-Learning Miami (ELM)
  - Regional Campus eMiami
  - Continuing Education (transitioning to Global Initiatives)



## International Higher Education

- Partnerships
  - Educational institutions
  - American non-profit providers of study abroad
  - Ministries of Education
  - Professional organizations with legal counsel (e.g. AACUPI)

- Expertise
  - Global partnership agreements
  - Study Away
  - Cultural
  - Geographic
  - Clery Act reporting
  - Communicating across borders and institutions
