- States maintain the authority to regulate out-of-state post-secondary institutions that offer or participate in activities located in their state.
- Institutions who participate in Title IV, HEA programs must comply certain provisions to operate, including holding appropriate state authorization and issuing important student consumer information, such as professional licensure disclosures.
- Consequences for noncompliance may vary, but could include fines, accreditation problems, lawsuits, cease and desist letters, barring licensure for regulated professions, and even the concern of bad publicity for the institution
