| International Admissions | SEVIS rules, sanctioned countries, internships outside the U.S., university international student policies, etc. |
| Controller's Office | Tax questions, consumer protection regulations, etc. |
| IT Security | Data privacy, GDPR, firewalls, access to course materials, OPM vetting, etc. |
| State Authorizations / Compliance Office | Professional licensure, certification, disclosures, recognition of degrees. |
| Registrar | Transfer of credit, evaluation of international credentials, etc. |
