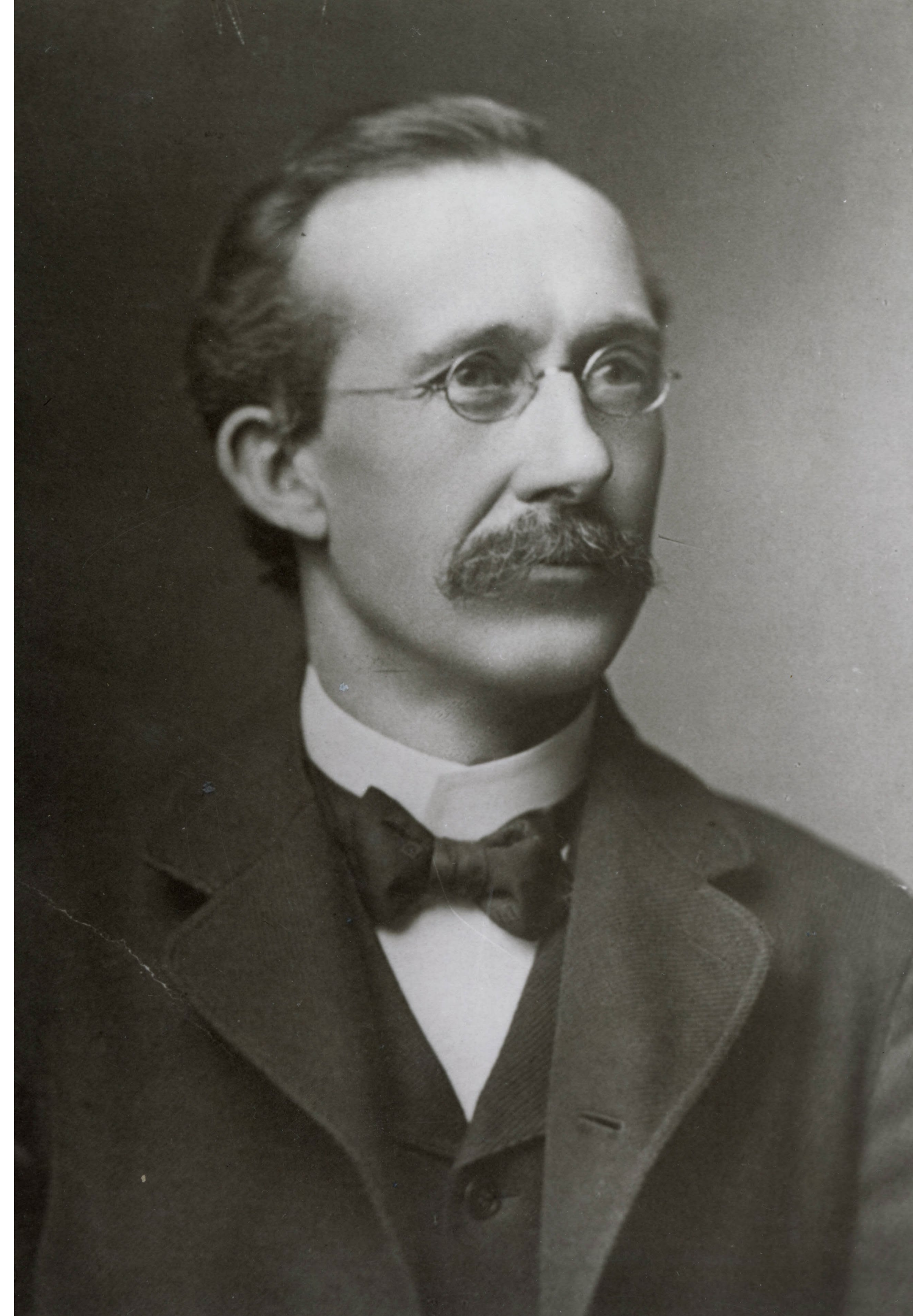

Refining the Process:

- Outdated and inaccurate student records caused initial false positives and, very likely, false negatives
- In response, we developed a process to prompt enrolled students to disclose updated learning location each term



Closing the Loop:

- We recognized the need for a centralized data hub for storing and monitoring state-authorization-related data
- This resulted in the NC-SARA Compliance Dashboard built on the SAS Visual Analytics reporting platform

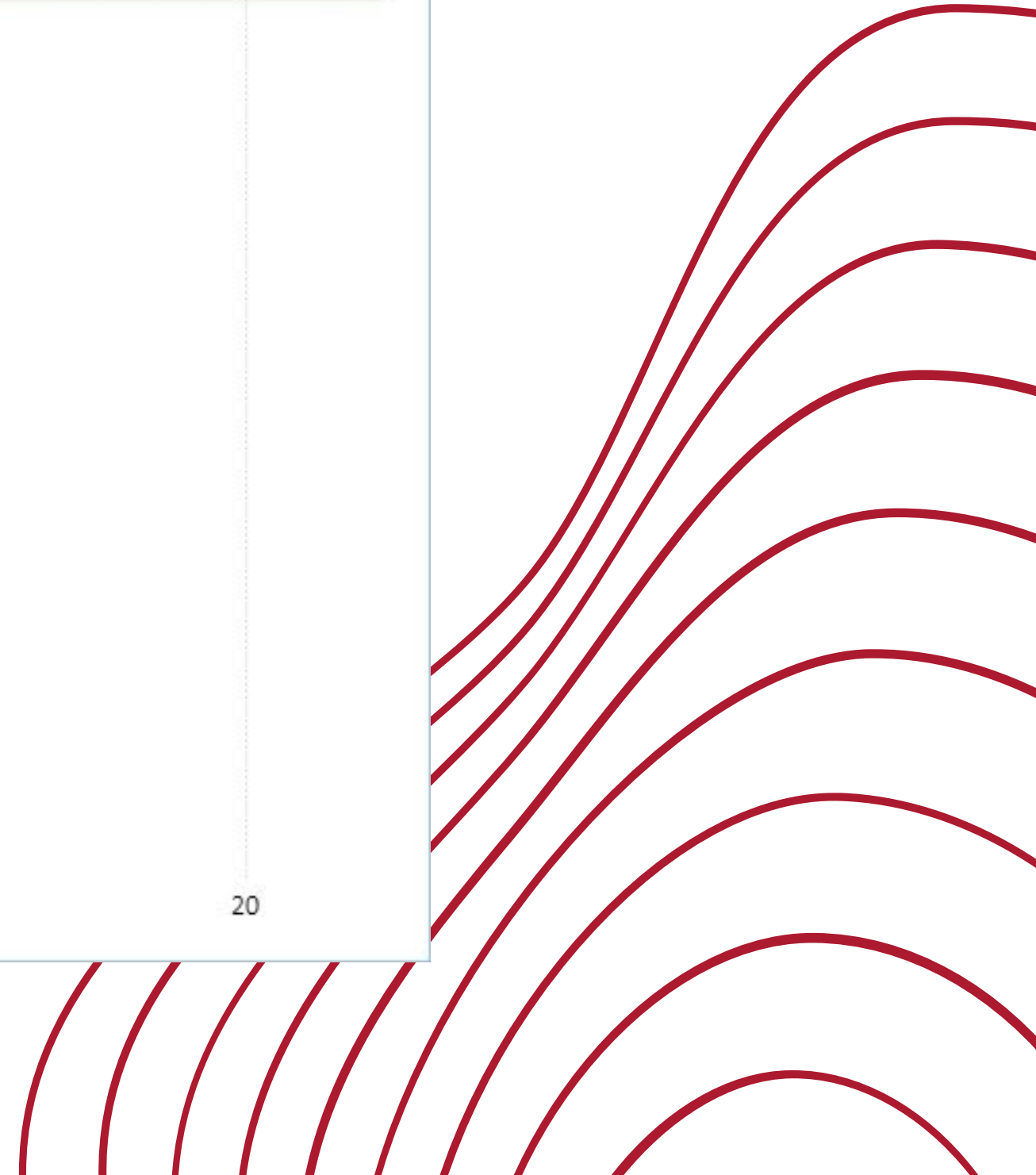
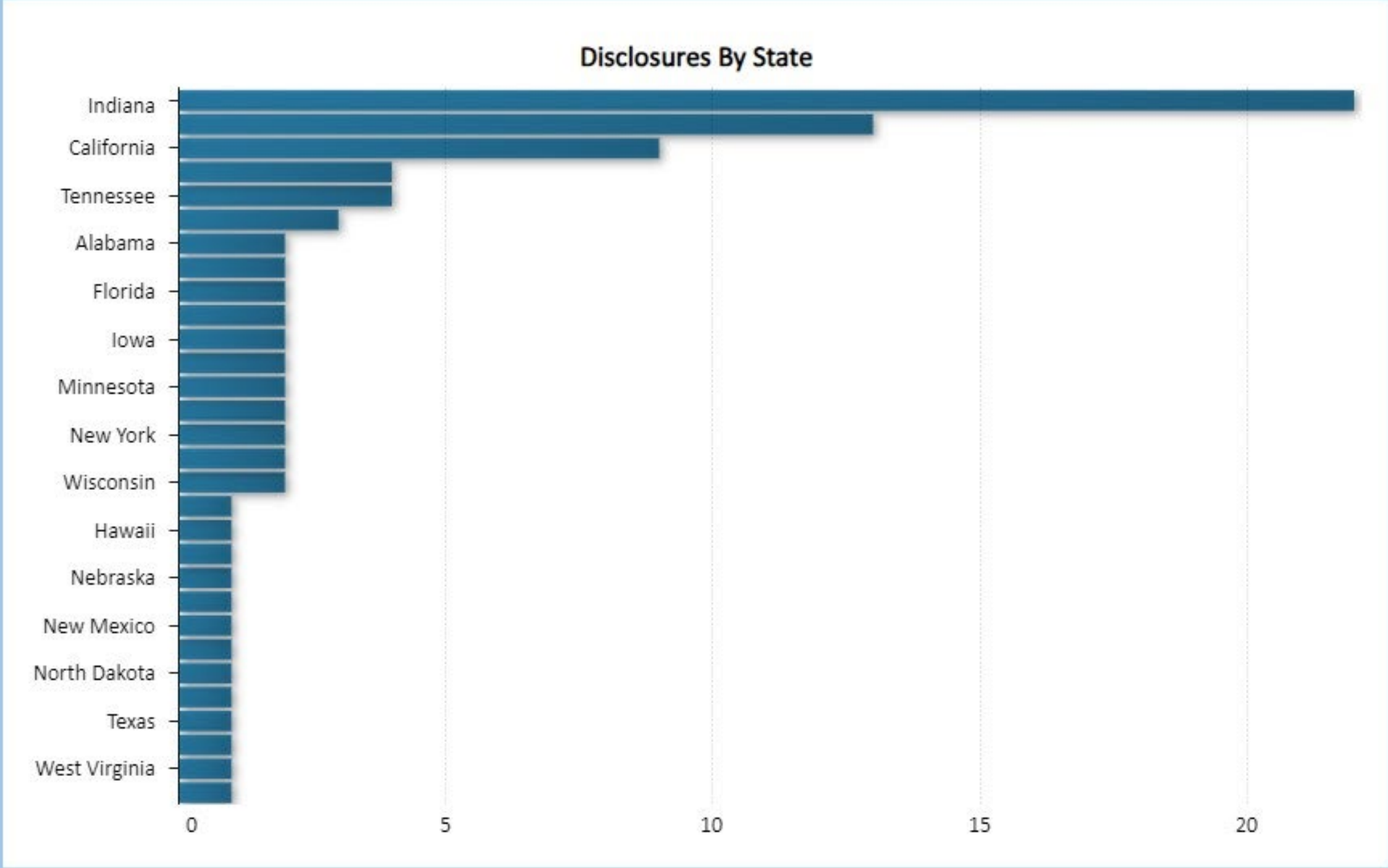
